A. Minutes of BOC Meeting: February 11, 2020

B. Financial Update-Dan Smith

Danielle reported she emailed Chief Smith to do a checking to savings transfer.

C. MPD Update-Dr. Hoffman

Dr. Hoffman reported on the Base Station that took place last week at Station 41. Good attendance, great speakers, and great questions. Talked about Protocols and testing. Many questions on Coronavirus and discussion took place on minimally systematic patients and whether or not to transport or not. Dr. Hoffman advised crews to use the Sepsis scorecard and to contact their Base station for further instructions. Instructions for this course of action will be sent out by Dr. Hoffman later today. Amy Evers mentioned that starting this Thursday, all visitors that come to the hospital will be checked for symptoms related to the Coronavirus. Discussion took place about how to get clean, verifiable, information out to our providers from Dr. Hoffman. Board members were asked to send Danielle names of a single point of contact that Dr. Hoffman could count on receiving an email or phone call if important information was needed to get out to the providers immediately. Discussion took place on the Destination Policy for Cardiovascular patients. This will be going to the Medical Officers. This is a required from the State for the STROKE and STEMI triage and destination on the EMS side. Board will wait to approve the Policy until the Medical Officers have time to review and give feedback.

DC Morevek discussed trying to get all departments on the same page even though the EMS website is staying up-to-date on the Coronavirus. He was looking for a directive in writing that lays things out for

the crews. Should departments be working under their own response directives? Chief Oliver mentioned that all the Fire Chiefs and Medical officers met last week and came out with a charge that they will develop a county wide IAP which was sent out yesterday.

Amy Evers spoke about a couple of recent trauma cases that occurred at the Hospital. She asked the Fire Chiefs to remind their medics that the hospital doesn't have neurosurgery. They had two cases that ended up being ground level falls on anticoagulants, both going in on rested. Chief Oliver asked Amy to please work with Dr. Hoffman on the two cases so he can get that info out to the Medical Officers.
