2. CONSENT ITEMS

Minutes of BOD Meeting: July 13, 2021

MOTION by Jeff Faucett approve the consent items, as presented. **SECONDED** by Jim Gillard. Motion **PASSED** unanimously by all members present.

A. Financial Update-

Danielle reported the balances in the checking and savings accounts.

B. MPD Report

Dr. Hoffman reported that he had the quarterly QI meeting. The group is looking at falls and refining the data set. In 2020, data showed approximately 2400 patients, that had a fall or needed lift assist. David Bailey and Kory Ambercrombie are working on the data set for ESO. Dr. Hoffman noted by refining the data set, a report can be run and used to launch a fall program in Kitsap county. Dr. Hoffman said he would lead the program. He would like a person from Saint Michaels to help with the missing links by getting those individuals who need Physical Therapy. John Viglo said Vanna Lombardi-Gillies, the Rehab Therapies Manager at SMMC would be the contact.

Dr. Hoffman and Joey Rodrigues were at a region meeting last week. Training requests should be coming out soon. Target cost is about the same as in the past. He spent a day in the supply room, pulled out surplus things, and getting ready for the EMT class. The EMT class is getting ready to start. The new edition of the EMT book has come out, He and Tamarah have been building a new E-Class for that. MPD meeting was on the 26th, the topic was behavior health. Discussion on DA renewal and the CSOS project for ordering controlled substances. Dr. Hoffman will be working with the other agencies to get them up and running. Tamarah reported Life-Assist for non-controlled substances, has the dr. signature to be



able to send over their life assist application can be mailed.

She made plans to get in touch with the volunteer person at S.t Michaels, she would like their check-in procedure and how to sign up EMT students for their hospital rotation dates. John Viglo said he can work the emergency room educator, Erin Rogers.

4. DISCUSSION / ACTION ITEMS

A. EMS Impacts of HB 1310



Jeff Menge reported that the language in the Bill created a lot of confusion. Interpreting the Law will be very important.

He spoke on how his division is doing small group meetings to discuss the new laws. The benefit of doing small groups is to allow the "what if" scenario questions.

Discussion on suicidal and medical calls and how LE will respond continued. Scene security was also talked about. Safety clearing of a scene will no longer happen. Mr. Menge discussed the new provision in the law that states for LE to leave the area prior to using any force if there is no imminent threat and no probable cause. Discussion continued on this and how to handle people who don't do well when LE is present.

Communicating with all personal on the scene before leaving is important.

Discussion continued on how to provide this training to Fire and EMS. Some suggestions were to have The Batallion Chiefs trained. Jeff mentioned he's willing to train Fire personnel if need be.

B. Pre-Hospital" waiting room" concept discussion

John Viglo reported that he, Chief Oliver, and Joey Rodrigues had a meeting to discuss using Olympic BLS Personal as a handoff from a field crew to a basic BLS waiting room to allow them to move in. Also to Utilize EMT's in the waiting room. The EMT's in the waiting room has already been implemented. Discussion continued on Hospital risk management and having the EMT's work within their scope of practice, reporting, and billing.

C. Mandatory COVID-19 Vaccinations for Healthcare Workers

Discussion on mandatory vaccinations and how the Fire Districts are handling it. Chief Teran communicated that it's important that all personal get vaccinated. BIFD looked at the Governor's mandate and his recommendation as well as when Phizer receives the full approval for the vaccination in September would be a good time to reach out to the unions on getting everyone vaccinated. Dr. Hoffman spoke on the EMT class requiring the COVID vaccination. Some have turned away and have withdrawn from the class. Field rotations will need all their vaccinations, N95 mask, and they will provide a copy of the COVID card to do the ride alongs.
