2. CONSENT ITEMS

Minutes of BOD Meeting: August 9, 2022

A. Financial Update-

Chief Dan Smiths reported the amounts in the checking and savings accounts.

B. MPD Report

Dr. Hoffman reported had attended the State MPD meeting which happens quarterly where standardized BLS protocols for the State was discussed. He mentioned that a lot of the content is being taken from the Northwest Region. He spoke on a big presentation from the National Registry of EMTs psycho motor exam for Paramedics and advanced EMTs. Dr. Hoffman also reported he had a few meetings with the Fire Chiefs and St. Michaels on ER wait times and diversion. Base station was held on Sept 1, 2022. Dr. Hoffman met with the four SCI's and the two candidates to discuss the training calendar and training standards. Finally, he has been working with Tamarah on the cadaver lab which will be held on October 11th and 12th, 2022.

Chief Faucett asked about SCIs and how many are needed. Discussion continued.

C. Monthly Staff Report

Danielle reported both timecards were submitted with the Board materials. Danielle reported that all bills and invoices are up to date. She reported that she's been working on a file project and cleaning up areas in old folders looking for documents that may have been missed in the merge. She reported that

the checking and savings accounts have been reconciled.

Tamarah reported that most of her time this month has been focused on recertifications where she's been reaching out to those individuals who still need to finish their training with personal letters. She also reported that all 2023 class applications have been signed by Jeff Faucett and filed with DOH, with the exceptions of the EMT class. She mentioned that the next EMT class will be held January 12, 2023 at the cost of \$1500. This cost will include cpr, background, and supplies. She's been working with joe Schweiger on a Bridge Course which is open to all districts. Tamarah will be sending out an announcement on this course as soon as she gets it. She's been working on the cadaver lab with Dr Hoffman. She reported that only three ALS slots are open and many BLS slots are still available.

3. OLD BUSINESS

A. CBD committee update

Chief Payne reported that he sent the CBD reconciliation draft to Dr. Hoffman, and it has been looked at and given back to the CBD committee for editing. Chief Payne reported that next month, the committee will see where Cencom is at with training and start pulling calls.

B. Chad Melton spoke on St. Michaels wait times. He mentioned he's being meeting with the Fire Chiefs and agreed to put together an EMS taskforce, to look at pre-hospital arrival, patient care to ensure everyone is meeting mutual goals. Mr. Melton shared his screen which showed holdings in other hospitals in the area. Discussion continued on wait times, processes, and the goal of the task force.

4. DISCUSSION / ACTION ITEMS

A. Law Enforcement Training Community Safety Act-New Policy

Chief Faucett reported that this is a future policy and procedures that the EMS office will be working on that will cover the "use of force" and how that applies to EMTs and Paramedics.

Jeff Menge from KCSO spoke on use of force laws, especially when the result is death, or serious bodily Injury, therefore, a policy such as this one that is needed especially because EMT and LE are intertwined.

B. Budget

Chief Faucett reported that in the next month a budget will be worked on for 2023. He's hoping to have a budget draft adoption in November. Chief Faucett reported that the EMS office will be requesting additional line items in the budget for EMT classes and future supplies for those classes.
