I. Purpose

To assist in gathering needed information in the case of the death or significant injury to a child.

II. Policy

Field providers shall complete a Child Death or Significant Injury Supplemental Report on all children under the age of eighteen (18).

III. Procedure

On all child deaths or suspected significant injuries:

- A. The provider or providers shall complete the Kitsap County Child Death/Injury Supplemental Report.
 - 1. The report should be completed within 24 hours of the call in conjunction with the EHR.
 - 2. Any observations or conversations seen or heard about the patient should be noted on the report.
 - 3. Any unavailable information should be noted as such (N/A).
- B. The provider or providers shall attach the “Child Death/Injury Supplemental Report” to the EHR as part of the permanent record.
- C. A copy of the Kitsap County Child Death/Injury Supplemental Report will be directed to Kitsap Public Health for review. Additionally, a copy shall be sent to the Medical Program Director.

If requested by Law Enforcement or the Coroner, the report shall be made available.
